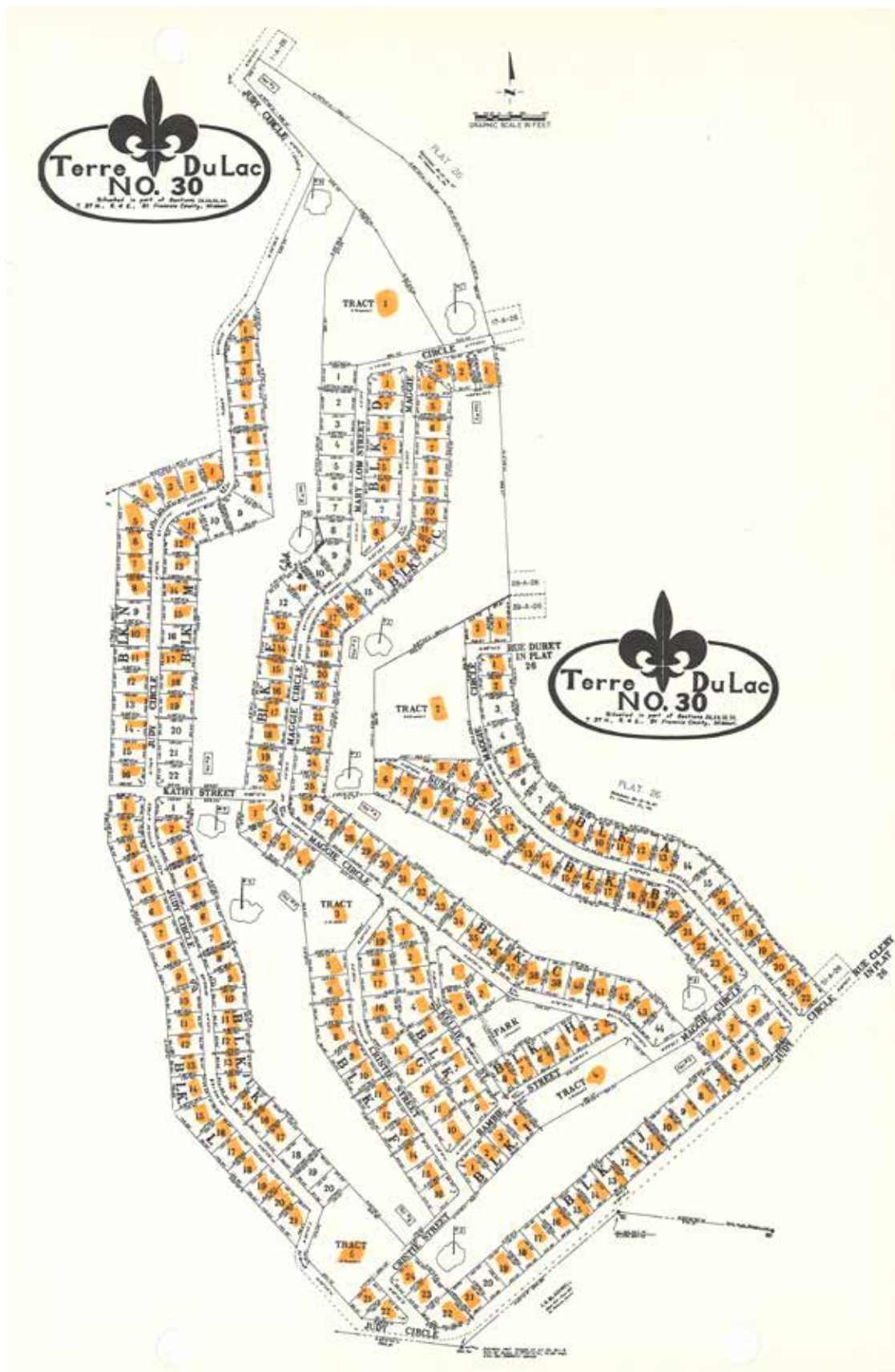
This Plat Amended Town of Lake Stevens Plat 128

To the Existing Town of Lake Stevens

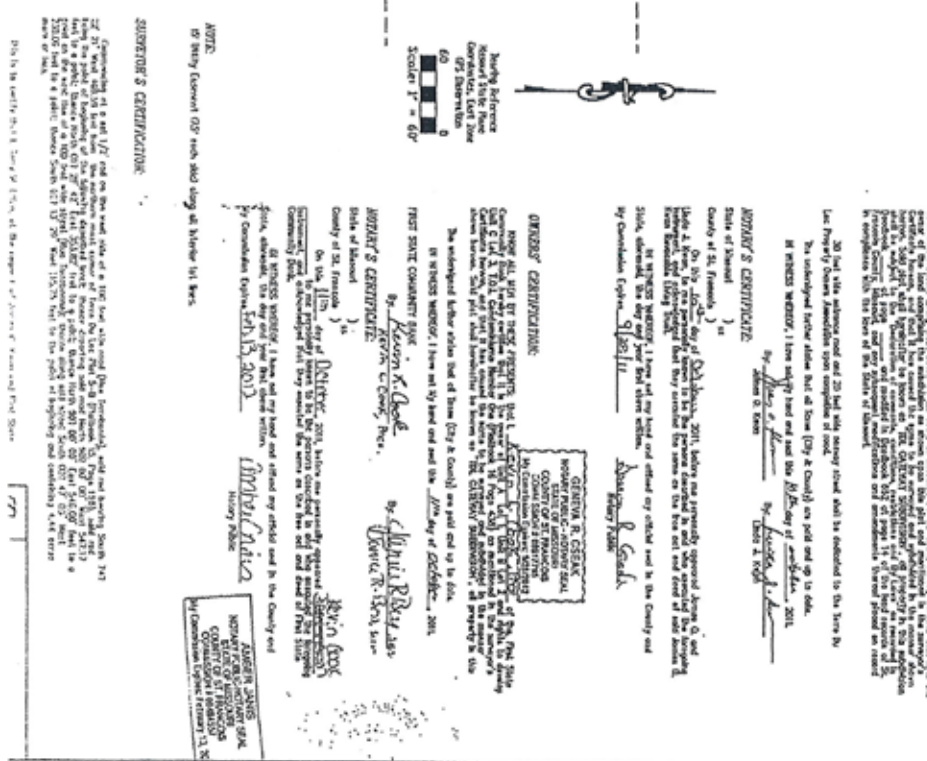
